Eligible entrants:	Entry is only open to QLD, SA and WA residents who are 18 years of age or over. .		
How to Enter:	To enter the Promotion, the entrant must complete the following steps during the Promotional Period: a) purchase two (2) Great Northern Super Crisp 375ml cans in one (1) transaction, to share, from any venue displaying advertising for this Promotion ("Participating Venues") and collect a game card at the time of purchase, while stocks last; and b) scratch the game card to reveal whether or not they have won a prize.
